EVPA MEMBER NAMED AS LIAISON TO THE LGBT COMMUNITY

Mayor Gavin Newsom announced the appointment of Jim "Jimmer" Cassiol as his point person for District 8 and the LGBT community in San Francisco. Jimmer is well respected for his commitment to the community. In addition to his duties as LGBT liaison, Jimmer will represent the Mayor in District 8.

"Jimmer has gone above and beyond his call of duty to support the LGBT community," said Mayor Newsom. "I know



that he will continue to advance the cause of equality, fairness and justice that every San Franciscan deserves."

Over the last several years, Jimmer has been active in a number of key groups, including serving on the Board of the Eureka Valley Promotion Association (EVPA), and as the only renter on the Board of the Small Property Owners of San Francisco. He is a member of the Alice B. Toklas Democratic Club, Plan C, is involved with the Merchants of Upper Market and Castro, and is active in the AIDS Emergency Fund. In addition, Jimmer has been involved with Merchants of Upper Market and Castro and is active with the AIDS Emergency Fund.

"I am proud to have been asked by Mayor Newsom to serve as liaison to the City's LGBT community," said Jimmer. "I have been an active part of the LGBT community for years and I am looking forward to serving this vital community and connecting people with services." District 8 Supervisor Bevan Dufty, whose district includes the Castro, praised the Mayor's appointment. "Jimmer has proved his talent and dedication since joining the Mayor's Office of Neighborhood Services. I welcome his involvement in the diverse range of LGBT issues that are so important to our

city. I know the community will find him to be welcoming, responsive, and hard working."

Treasurer Jose Cisneros also acknowledged the appointment saying, "I have known Jimmer for several years, and I am confident that he will serve as a great asset to the gay and lesbian community. I am confident that this appointment will be of real benefit to the LGBT community, and to the city of San Francisco as a whole."

EVRC CONSTRUCTION UPDATE

General contractor, Kin Wo Construction, began its contract work on February 9, 2004. At this time, the building shells are complete and electrical, mechanical, and plumbing systems are in place. Drywall installation to "close up the walls" is currently underway. The project is approximately 69% complete. The City continues working closely with the contractor on the expeditious completion of the project and will continue to track the contractor's progress so that the recreation center and playground can open by the Commission approved Fall 2005 deadline. Work to be completed in the coming months includes finishing the interior spaces, the installation of the art work in the lobby and entrance pillar by Artist Vicky Saulls, completion of site ramps, walkways, planters/landscaping and the playground.

PTPM HAS A NEW NEIGHBOR

Pink Triangle Park and Memorial will soon have a new neighbor. Deborah Udin, a Zephyr Real Estate sales manager and broker, confirmed that 2500 Market Street had been leased. Ms. Udin said, "the interior of the building

will be configured as private offices and conference rooms and act as a satellite to the main office." Zephyr's 2500 Market Street office is scheduled to open early September.

"The fit couldn't be better," EVPA member Pauline Shaver said. "Zephyr has long supported the human rights concerns and PTPM was dedicated on December 10, 2001 the day Mayor Willie Brown declared Human Rights Day in San Francisco."

Self-described as "as a caring, funloving family of agents who take a hands-on approach to community service," we learned from Zephyr's website that they participate in various charities and local causes each year. From human rights, to breast cancer research, and youth and children's organizations, the list was most impressive and we have included a few here.

Rebuilding Together. National charitable event takes place on the last Saturday of April and provides badly needed home repairs and improvements to elderly or disadvantaged homeowners who are unable to maintain their homes. Each year, Zephyr management co-sponsors a home and Zephyr agents volunteer to do the labor, including painting, hauling, garden clean up, and minor carpentry.

As a result of a 2003 grant application, EVPA has been awarded \$1,400 from the Mayor's Neighborhood Beautification Fund (NBF) for improvements to the Pink Triangle Park and Memorial at the Market/Castro/17th Street intersection. We are grateful to Lanita Enriquez, Program Director, and the Fund's Board for selecting us for this award.

The award will fund continuing improvements at the park, including new plants, bark mulch, repairs to the irrigation system, and other maintenance items. We are excited to be sprucing up the park in time for Gay Pride weekend later in the month, a time when many people visit our neighborhood, and hope you will all visit and enjoy the blooming roses and sculpture when you are in the area.

When combined with the \$400 generously allocated to the park via EVPA's 2005 budgeting process, the Neighborhood Beautification award will serve as a base to continue the ongoing maintenance of this unique park and memorial.



ROBERT EARL HALE REMEMBERED

I passed IXIA recently and noticed a memorial in the window. The arrangement of flowers announced the passing of a generous and gentle individual. Robert Earl Hale, unique in everyway, was a talented floral artist, whose innovative work has complemented many EVPA events. He was born on January 18, 1958 and died on April 28, 2005.

Many of us will remember Robert's contribution to EVPA's dedication ceremony of Pink Triangle Park on Human Rights Day (December 10), 2001. At that time, the park project was at a critical stage in its development. EVPA volunteers had been successful in establishing a rose garden on the city owned triangle lot near the Castro/Market intersection. San Francisco sculptor, Susan Martin and designer Robert Bruce had generously contributed their expertise to create a memorial to LGBT victims of the Nazi regime. But city funding of additional improvements (such as an irrigation system) was still uncertain. Organizers of the dedication ceremony were hopeful that the event would raise the profile of the park project and show its potential as an important landmark for San Francisco.



The winter of 2001 had been particularly rainy. Contingencies such as a huge tent and complimentary umbrellas had been considered. But luckily the morning of December 10 was one of those clear and sunny days between storms. The park was green, but (because of the season) lacked the explosion of rose blooms that had become its trademark. Robert Hale was the first to arrive at the park to prepare for the ceremony. He had brought stacks of huge long-stem pink roses (donated by EVPA member Gary Weiss). Robert instructed us on the arrangement of the roses which would climb a 10-foot high bamboo frame. Robert worked slowly and methodically as he trained the rose blooms to show at their best. The frame he lovingly crafted was placed "center-stage" behind the speaker's podium.

Pink Triangle Park announced itself as a human rights memorial on that sunny morning in 2001. Local politicians and park organizers spoke in front of a brilliant backdrop framed by Robert Hale's gate of pink roses. 50 years after the signing of the UN Declaration of Human Rights, two years after the planting of the first rose bush at Pink Triange Park and three months after the World Trade Center tragedies, Robert's work confirmed that magic could be reality.


